Provided all requirements are met pursuant to Va. Code §§ 46.2-750, 46.2-750.1, or 46.2-1187.3, DMV issues non-official use license plates (also referred to as "blind" or "confidential" license plates) to vehicles owned by:

- · State and federal government agencies,
- · Political subdivisions and their agencies, and
- · Local or regional economic development authorities,

DMV may also issue non-official use license plates to other government owned vehicles when it is shown that:

- The vehicle will be regularly used in the course of official business, and
- The use of non-official license plates is essential to the performance of that official business.
